EXTENSION OF THE COMPLETION DAY

Pursuant to the terms of the Subscription Agreement, Completion was intended to take place on the Completion Day, being 6 January 2020 or any other day agreed by the parties to the Subscription Agreement in writing.

In view of the additional time required for certain conditions precedent set forth in the Subscription Agreement to be satisfied, being the Subscriber obtaining governmental approvals required for the Subscription and the transactions contemplated thereunder, on 6 January 2020, according to the provisions of the Subscription Agreement, the Subscriber and the Company agreed and entered into a written confirmation letter (the “**Extension Confirmation Letter**”) to extend the Completion Day to 15 January 2020 or any other day agreed by the parties to the Subscription Agreement in writing.

Due to the same reason sets out above, the Subscriber and the Company agreed and entered into another written confirmation letter on 15 January 2020 in accordance with the provisions of the Subscription Agreement and the Extension Confirmation Letter to further extend the Completion Day to 18 February 2020 or any other day agreed by the parties to the Subscription Agreement in writing.

This is a voluntary announcement made by the Company for the purposes of keeping the Shareholders and potential investors of the Company informed of the latest progress of the Subscription. The Company will make further announcements to update the Shareholders and potential investors of the Company as to the development of the Subscription and the Completion as and when appropriate.
